OFFSHORE POWERBOAT LICENCE APPLICATION

HOW TO APPLY AND THE REQUIREMENTS FOR ISSUE

All UK residents who wish to take part in Powerboat Racing in the United Kingdom or the Republic of Ireland must hold a valid Powerboat Racing licence issued by the Royal Yachting Association.

All UK residents who wish to take part in International racing must hold a valid International Powerboat Racing licence issued by the Royal Yachting Association.

Licences available are as follows:

1. PROVISIONAL LICENCE – this licence is issued to all newcomers to national racing. Competitors are required to undertake a Powerboat Race Training programme, full details of which can be found in RYA Powerboat Race Training handbook, PB3 and on the RYA website. On satisfactory completion of this training and written proof of competency, the RYA will issue a Provisional Powerboat Racing licence which can be upgraded to a full national licence after successfully competing in four Offshore Powerboat racing events. Competitors are required to present their Powerboat Racing Upgrade form to the Officer of the Day prior to the Drivers' Briefing; this will be signed by the Officer of the Day at the end of the event providing he is satisfied with the competitor's performance.

Note: The Officer of the Day will require competitors to take a written/oral test prior to racing and demonstrate that they fully understand the racing rules particularly those relating to overtaking and rounding of race marks, together with a full understanding of the International Regulations for the Preventing of Collisions at Sea (G2).

- 2. NATIONAL LICENCE this licence is issued to:
 - a) Successfully upgraded Provisional licence holders
 - b) Previous holders of National licences (issued within the last two years)
 - c) Foreign competitors who are resident within the UK and wish to take a UK national licence must:
 - i) Have written permission from their own National Authority.
 - ii) Proof of previous racing experience by the submission of a Powerboat Racing CV with their Licence Application Form.
- 3. INTERNATIONAL LICENCE this licence is issued to:
 - a) Previous holders of National licences (issued within the last two years).
 - b) Foreign competitors who are resident within the UK, who wish to take an International licence must have written permission from their own National Authority to be issued with an International licence.
- 4. UIM SUPER LICENCE this licence is issued to:
 - a) All competitors who race in UIM, Class I or UIM X Cat must in addition to their UK International licence hold a UIM Super Licence.
 - b) UIM Super Licence application forms and procedure can be downloaded from the RYA website www.uimpowerboating.com/vsite/vnavsite/page/directory/0,10853,4916-194213-211436-nav-list,00.html or www.uimpowerboating.com
 - c) UIM Super Licence applicants are reminded that an additional UIM medical examination is required

and that the deadline for a Super Licence is six weeks before you require it.

5. EVENT LICENCES: (purchased at each event and issued by Race Secretaries):

An Event Licence provides a competitor with a temporary Powerboat Racing licence valid only for the duration of the event at which it was issued and restricted to the class as authorised by the Event OOD and signed by the Race Secretary.

Racing with an Event Licence does not make you eligible for National Championship points.

A "Medical Self Declaration" form must be completed and signed by the competitor prior to the issue of **each** Event Licence and only a **maximum of two** can be issued with a MSD.

From 2012 Event Licences are now unlimited - after the issue of two with MSDs a full medical is then required if a competitor wishes to continue racing. They must then apply to the RYA for an Annual Powerboat Event Licence (APEL) and Log Book.

Criteria for Unlimited Event Licences, as above, the competitor must apply to the RYA Office for an Annual Powerboat Event Licence and Log Book. This is done by filling out the usual Licence Application Form (which now carries a tick box section related to the APEL). This application must be accompanied by a full RYA Powerboat Racing Medical completed by the competitor's GP, passport photographs, Proof of Training, and if required, a current immersion test certificate. The competitor will then be issued with an Annual Powerboat Event Licence and Log Book, which must be presented to Race Control on "signing on" where the Event Licence Fee of £75 must be paid per event and the Log Book completed by the Race Secretary.

All competitors with no previous racing experience are required to undertake a Powerboat Race Training programme prior to an Event Licence being issued. On satisfactory completion of this training the RYA will issue an Event Licence. Full details of the Powerboat Race Training programme can be found in the RYA Powerboat Race Training handbook PB3 and also on the RYA website.

Note: The Officer of the Day will require new competitors to take a written/oral test prior to their first racing event and demonstrate that they fully understand the racing rules particularly those relating to overtaking and rounding of race marks, together with a full understanding of the International Regulations for Preventing Collisions at Sea (G2).

Competitors who have previously held a Powerboat Licence or Event Licence within the last two years will be eligible for an Event Licence without them having to undergo training. The RYA will send a list of all such qualified competitors to RYA Race Secretaries at the start of each new racing season.

Event Licences will be stamped prior to the race by Race Secretaries to confirm a competitor has paid the fees due and that the paperwork is in order. The competitor will retain his **Annual Powerboat Event Licence and log book** for presentation at any future events.

Event Licences will Cost £75 per event.

Note: If a competitor wishes to race with a full RYA licence there will be no reduction in the full licence fee to accommodate any Event Licence charges that have been made.

Note: If a competitor wishes to race with an Annual Powerboat Event Licence and Log Book, they must allow adequate time to undertake a medical, fill out the Licence Application form and submit to the RYA a minimum of 14 working days before they actually require the APEL, or the normal fast-track fee will be applied.

If a Competitor wishes to apply for an APEL in advance of their first event they can do so providing all the relevant paperwork is in place. No payment will be required until their first event of the season.

- **6. POWERBOAT RACING LICENCES FOR THOSE UNDER 18** (ie those who are not yet 18 when they apply for their licence):
 - a) All competitors under the age of 18 are required to submit an RYA Certificate of Competence Form signed and completed with their Licence Application form on an annual basis.
 - b) RYA Officials who countersign a Certificate of Competence form are reminded that it is their responsibility to ensure that the named competitor has undergone a Powerboat Race Training programme, and in their opinion, is competent to participate in Powerboat Racing for the classes identified on the competitor's Licence Application Form.
- 7. IMMERSION TESTS If you are racing in a class that requires an Immersion Test ie restraint and canopy boats, then you must have undertaken your test before applying for your licence. See RYA website for details of venues and dates when tests are being offered.

8. WHAT DOES THE POWERBOAT RACING LICENCE PROVIDE FOR YOU?

All competitors are provided with Third Party Public Liability insurance whilst racing and during official practice. This cover only applies once the competitor has "signed on" at Race Administration at the beginning of the event. All such cover ceases once the competitor has "signed off".

The RYA Powerboat Racing Department is now pleased to offer specialist insurance for Powerboat Racing to all RYA licensed Powerboat competitors. The RYA can now provide insurance for raceboats and their equipment both whilst in transit to and from RYA events and also can provide insurance cover for competitors' boats whilst racing. Full details are enclosed with this application and can also be found on the RYA website.

THIRD PARTY LIABILITY INSURANCE IN UNITED KINGDOM

Payment of the licence fee automatically ensures that the holder is subject to the terms and conditions of the insurance effected on behalf of the insurers to the RYA for and on behalf of its recognised clubs and members jointly indemnified with the RYA in respect of legal liability for death or bodily injury to persons or damage to property following accident whilst taking part in any powerboat race approved by the RYA and organised by one of its recognised clubs.

The policies will also indemnify any holder whilst taking part in such official practice as may be defined in the advance programme or by the race committee at the time of the event.

The limit of indemnity is £5,000,000 on water and £10,000,000 on-shore for any one accident, with an excess of £1,000 and £2,500 respectively. Payable by the organising club/competitor.

OVERSEAS THIRD PARTY LIABILITY INSURANCE – This is automatically included with an international status licence.

This means that holders of international licences participating in worldwide events, (excluding the United States of America and Canada), will automatically receive a cover note (insurance letter, or licence endorsement), to extend the conditions of the insurance applying to the UK – this insurance only comes in force if the race organiser's own insurance fails – the RYA cover is not the PRIMARY LAYER. Competitors MUST purchase the organiser's own insurance at UIM recognised foreign events.

The limit of indemnity is £5,000,000 on-water only for any one accident when racing overseas. Competitors must provide their own insurance for races held in the United States of America and Canada.

10. WHAT DOES THE POWERBOAT RACING LICENCE NOT PROVIDE FOR YOU?

- a) The RYA insurance policies do not cover competitor to competitor liability.
- b) The RYA policies do not cover Personal Accident and Death benefit.

The RYA strongly advise that you take out the following insurances before racing:

- c) Personal Accident and Death Benefit.
- d) Legal Expenses cover.
- e) Loss of Earnings insurance.
- f) Travel and Medical Insurance (when travelling to foreign events)
- g) All Year Round Third Party Public Liability or Comprehensive cover on your boat/ski (outside of RYA organised Powerboat Racing events).
- h) Fire, Theft insurance cover on your own craft/trailer check to see if your car policy covers trailing.
- i) Check all your insurance policies to ascertain whether you are covered whilst Powerboat Racing. It is imperative that you declare this.
- j) ALWAYS SEEK INDEPENDENT PROFESSIONAL ADVICE IN INSURANCE MATTERS.

PART 2A - MEDICAL NOTES FOR THE EXAMINING DOCTOR:

Competitors in powerboat races held under the jurisdiction of the RYA and the RYA affiliated clubs are required to pass the RYA approved medical examination.

No Powerboat Racing licence will be issued until the Medical Examination Form is completed and signed by a Registered Medical Practitioner.

Event Licences however are subject to "self declaration" only and a signature by a Medical Practitioner is not required.

Competitors are required to declare any physical or mental disability.

Competitors must sign the declaration which permits the RYA to request details of their medical history from their General Practitioner or from any hospital or other practitioner.

For this reason the examining Doctor is asked to ensure that his full address in entered upon the form.

The fees for the Medical Examination and any Specialist Examinations are the responsibility of the applicant (competitor) and not the RYA, and would normally be expected to follow the guidelines currently recommended by the BMA.

The medical examination should be carried out to a standard similar to that required for Life insurance.

Diabetics may apply to the RYA Medical Officer for the issue of a licence to be considered.

Epileptic applicants will not be issued for a licence to race.

Applicants who have had, or still suffer from the following may be regarded as unfit to hold a powerboat licence:

- (i) Myocardial infarction
- (ii) Myocardial ischaemia
- (iii) Coronary artery by-pass surgery
- (iv) Serious valvular disease of the heart or other cardio vascular conditions which give rise to cardiopulmonary problems
- (v) Severe hypertension which has given rise to cardiopulmonary problems
- (vi) Misuse/abuse of alcohol or illicit drugs in the last 3 years

Amputations of any type could be incompatible with fitness to race apart from minor amputations of one or two fingers where the normal function of the hand is unimpaired. Absence of a thumb could also be incompatible with fitness. Where the functioning of the limbs is limited free movement should not be less than 50% or normal capability.

Patients requiring the use of any orthopaedic appliance should declare this so that specific consideration can be made of the case by the RYA Medical Officer.

Eyesight:

Normal binocular vision is required with full visual fields, normal eye movements and normal stereoscopic vision.

Normal colour vision is required. (Note: if colour deficiency – this can be referred to RYA Medical Officer for second opinion) The vision in each eye to be at least 6/9 either before or after correction

If glasses or contact lenses are worn this should be stated on the form

Contact lenses may be worn provided there is reasonable vision in both eyes without the lenses in place.

The visual acuity in each eye to be stated both with and without the contact lenses in place

The examiner should bear in mind that powerboat racing may take place at high speeds over turbulent water in confined areas, or upon waters used by the public, when considering the suitability of the application (competitor).

- a) I will not take any action which brings the UIM, the RYA or the sport into disrepute.
- b) I agree to be bound by the rules of the UIM and the RYA, and will not compete in any unauthorised event. I confirm that my application meets these requirements.
- c) I do not hold, and will not apply for a licence from another national authority whilst my RYA licence remains valid.

- e) I have read and understood the General Racing rules in the Offshore Racing handbook PB1, the class specific rules, to which my licence refers, and the International Regulations for Preventing Collisions at Sea (IRPCS) (Part B, sections I & II of RYA G2).

 - I am aware that Harbour Authorities apply bye-laws and regulations and I agree to conform to such bye-laws and regulations when using their waters.

f) Identification of Risk

I am fully aware and conscious of the actual and potential risks involved in active water sports, including drowning, hypothermia, physical injuries or death.

I accept that, by engaging in active water sports, my physical safety could be endangered. I am also aware that other competitors' actions, or inactions of the organisers of water sports events, including the drivers of safety craft, can also endanger my physical safety.

g) Acknowledge of Risk

I acknowledge that it is up to me personally to assess whether any event or activity on the water is too difficult for me or my crew. I acknowledge that the safety of my boat and her entire management including insurance is solely my responsibility, and I am satisfied that the boat and crew are adequate to face the conditions that may arise in the course of the race.

I acknowledge that scrutineering does not constitute a condition survey of the craft and it is solely my responsibility to decide whether or not to start or to continue in any powerboat race. I acknowledge that the efficiency of the helmets and racing vests worn is solely my responsibility.

h) I have read, understood and agree to abide by the rules set out in PB1 (National Offshore Racing rule book).

NOTE: THE RYA RESERVES THE RIGHT TO REFUSE THE ISSUE OF A POWERBOAT RACING LICENCE APPLICANT'S SIGNATURE. If the applicant is under the age of 18 years this declaration shall be countersigned by parent or guardian. Such signature shall be deemed as approval for the RYA to issue the licence for which application is made. If applicable, Parent or Guardian's Signature.

IMPORTANT NOTES

LICENCE APPLICATIONS BY NEW COMPETITORS FOR RB12

All new competitors or those who have not held a powerboat racing licence within the last two years who wish to participate in Round Britain 2012 must have a minimum RYA qualification of Advanced Powerboat or foreign equivalent. Competitors will be required to submit a detailed CV of their racing or boating experience to the RYA powerboat racing office. Applicants may also be required to take a theoretical examination so that the RYA can determine their level of experience prior to granting a licence. All RB12 competitors must have an International Licence in order to be eligible to compete in this event. For more information please contact the powerboat racing office: 023 8060 4240.

Marathon Competitors are further reminded that an International Marathon Licence is required for the Cowes Torquay Cowes event.

DRUG AND ALCOHOL ABUSE – The Powerboat Racing Division has a ZERO tolerance policy on this, and it would fall under "bringing the sport into disrepute". The medical section of the Licence Application Form has a question relating to any abuse in the past three years. We expect people to be in control of themselves and their craft.

ANTI-DOPING - TUE FORMS

If you are taking drugs for medical reasons which contravene the list of prohibitive substances, you will need to fill out a TUE (Therapeutic Use Exemption) form enclosed and return it with you completed licence application form – you only need to complete this form if you are racing internationally.

DECLARATION OF MEDICAL FITNESS TO RACE – All fully licensed competitors are required to have a medical examination on an annual basis before the issue of their new documentation. At each race competitors are asked to sign a "declaration of fitness to race" whether they are fully licensed or not, we believe that on some occasions there have been a few whose level of fitness has declined during the season, either through accident, injury or illness. It is imperative to make sure that you are fully fit before participating in an event; bear in mind that to try and recover a fit person after a racing accident is difficult enough, without the added anxiety of trying to recover someone who shouldn't have gone out in the first place. Your actions could have repercussions on our third party insurance – PLEASE THINK CAREFULLY BEFORE PARTICIPATION.

IN THE EVENT OF INJURY:

If you are injured during a Powerboat Racing Event and are sent to hospital for examination or treatment, then your licence will be withdrawn by the organisers (a PB19 form is filled out and your licence returned to the RYA). You will be sent a copy of the PB19 form and you must get a doctor's signature declaring you fit before you can race again, and your licence will be reissued.
